NEW BUSINESS

Resolution Regulating Smoking in Public Places during Settler's Days

Students from the Marengo Chapter of Reality Illinois spoke to the Council about the proposed resolution before the Council this evening. The group had discussed this possible resolution with a representative from Settler's Day Inc, and that person felt that it would not be a problem for them to follow the City Council's direction in this matter.

Alderman James Regelin made a motion approving the proposed resolution regulating smoking in public places during Settler's Days. After further discussion by the Council members, he withdrew his motion. It was recommended that Skinner's Amusements be made aware of this new regulation.

Alderman Nicole DeBoer made a motion, seconded by Alderman James Regelin, to approve the resolution - with the exception that it is only pertaining to the carnival area making it a "Smoke Free" area regulating smoking in public places during Settler's Days. The aldermen voted as follows:

Authorization to Execute Change Order #1 to Water Main Replacement Project City Engineer Hartnett presented the change order to the Council, showing the change in the work to not construction Alternate No. 3 - which provided a second connection to State Street at the north end of the project. This will reduce the contract amount by \$73,205.04 – for a new total of \$885,694.76.

Alderman Nicole DeBoer made a motion, seconded by Alderman Steve Mortensen, for authorization to execute Change Order #1 to the Water Main Replacement Project (to remove option #3). The aldermen voted as follows:

Assistant City Administrator Joshua Blakemore provided an update on the transite project. Spoke about the WWTP status and explained about some "bugs" that they were working through. Also advised that the City would start the hydrant flushing tomorrow.

Finance Director Jennifer Snelten advised the Council that the month end report was included in their packet, effective April 30, 2015. She invited the new aldermen to stop by her office so they could meet with her and look over the budget and answer any questions they might have for her.

Sergeant Riley filled in this evening for Chief Hallman, who had submitted a written report in the board packet.

City Engineer Tim Hartnett reported that they (HR Green) have been invited to meet with the bridge designers for the toll-way on June 1st. The design team will have 30% of the plans done for the bridge. HR Green will provide everyone with the current status on data collected, and will then collaborate on schedules and timing of where everyone is at in this process.

City Administrator Gary Boden spoke on the current municipal funding situation with the State of Illinois.

City Attorney Carlos Arevalo had no report.

City Clerk Connie Boxleitner reminded the two newly elected aldermen about the need for them to complete the OMA certification, and to be sure and provide a copy of the certificate to the clerk's office.
